CONSULTATIONS: Consultation appointments are essential for the bride. One hour is scheduled for a complete walk through of the style. Consultation should be scheduled prior to your big day!

BOOKINGS: To secure a date and scheduled makeup times a signed contract is required with a deposit in the amount of 50% of the total package cost at the time of signing. The deposit is non-refundable and non-transferable.

In the event that the contracted Makeup Artist is unable to perform the services agreed upon due to an emergency, illness, or unexpected occurrence a trusted substitute Makeup Artist/ Hair stylist will be assigned and informed of the contracted and discussed arrangements.

Please ensure that every person listed on the contract is on time for their scheduled services. We need a certain amount of time per person to give quality service.

SERVICE LOCATION AND REQUIREMENTS: For Hair and Makeup services, please ensure the location temperature is cool and not hot so that makeup and hair will set properly. Ample lighting is also required, whether natural or generated.

TRAVEL FEE: Flat fee per makeup artist of ₱ _____ will be paid by the client for travel to the location, unless provided directly by the client.

MEALS: Client agrees to provide meals for the Hair and Makeup Artists during the day(s) of the event.

LIABILITY: All brushes and makeup products are kept sanitary. All products are sanitized between every makeup application. Any skin conditions or sensitivities of the client(s) should be reported by the makeup artist prior to application, and if needed a sample test of makeup may be performed on skin.

PAYMENT: The final balance is due on the day of the event prior to services. Cash, Debit and Credit Card payments are accepted. The Person(s) responsible for the entire balance of payment is the person(s) who has signed the booking contract.
